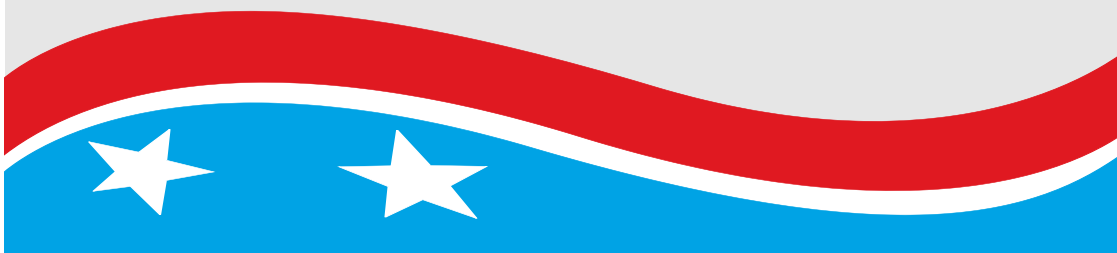

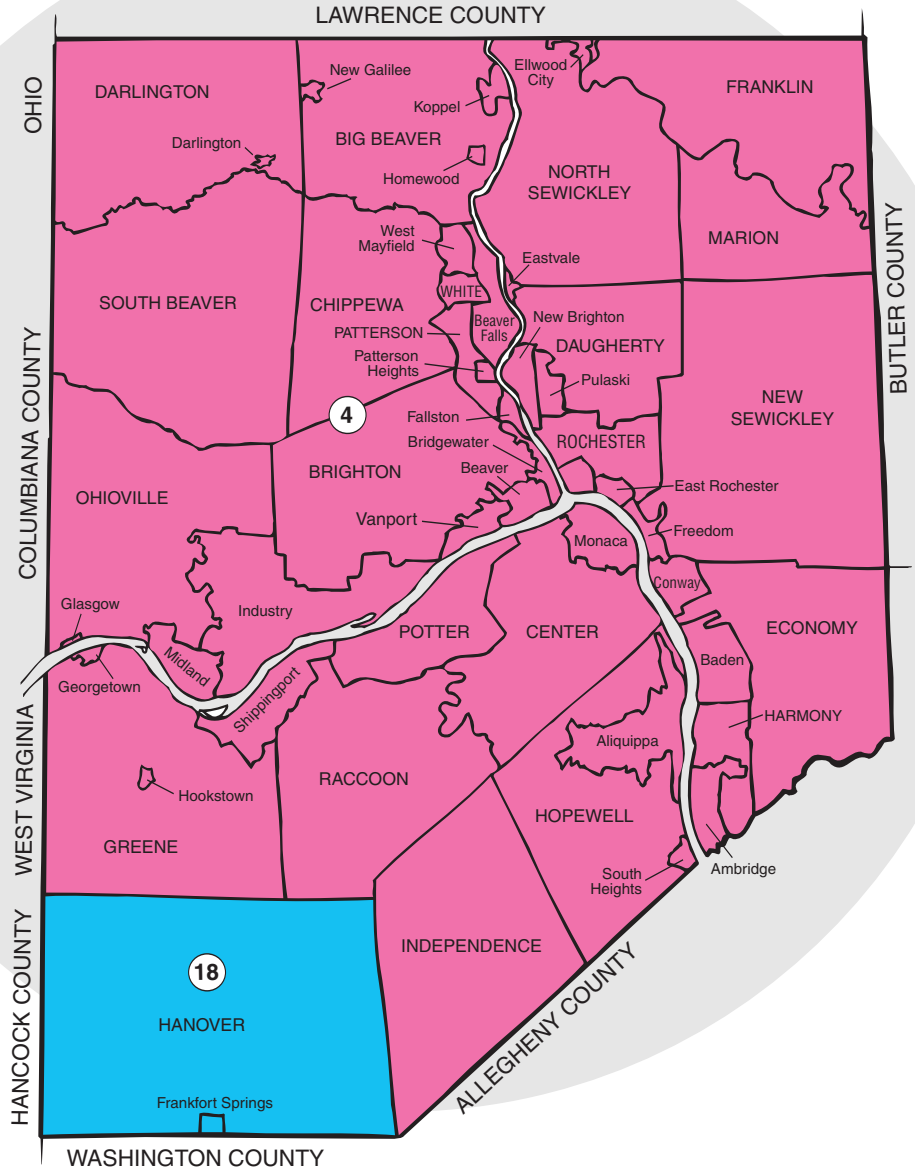

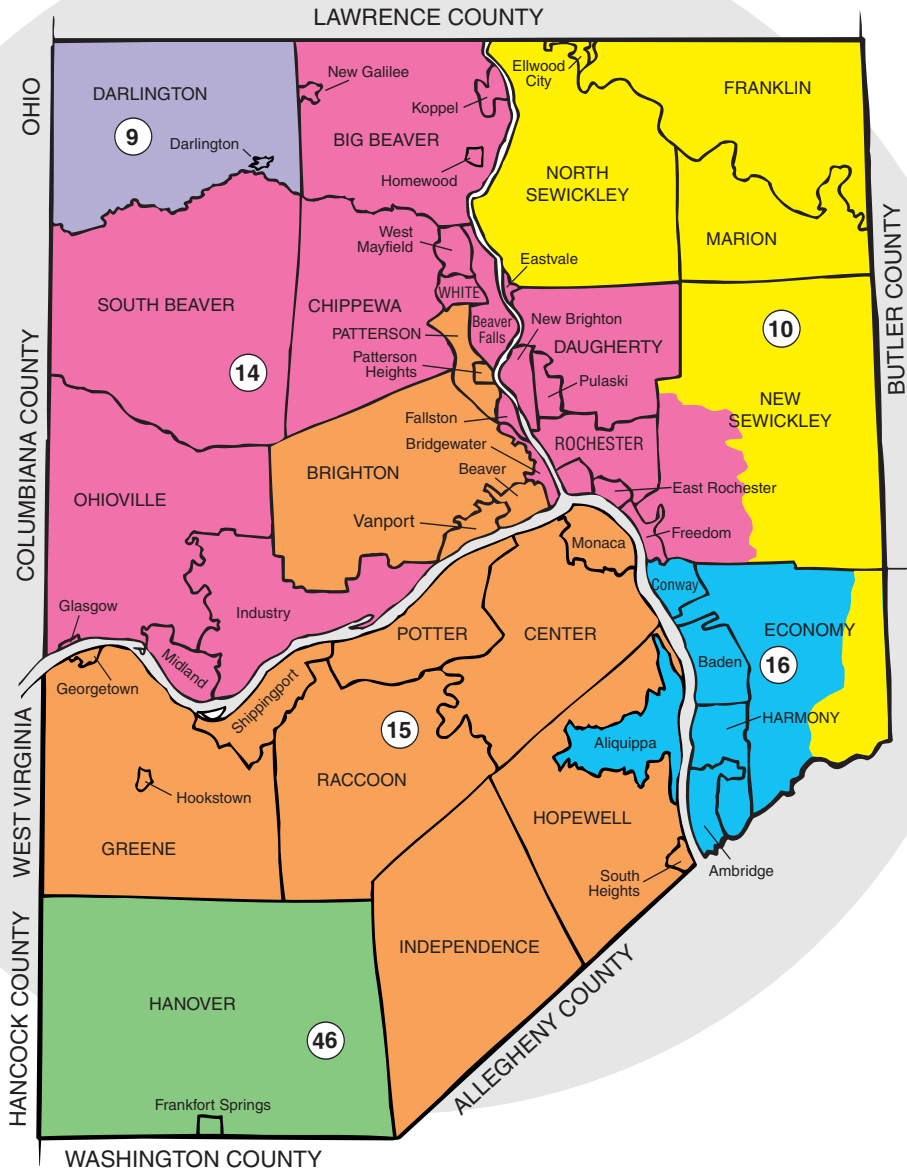


## Letter Writing Tips

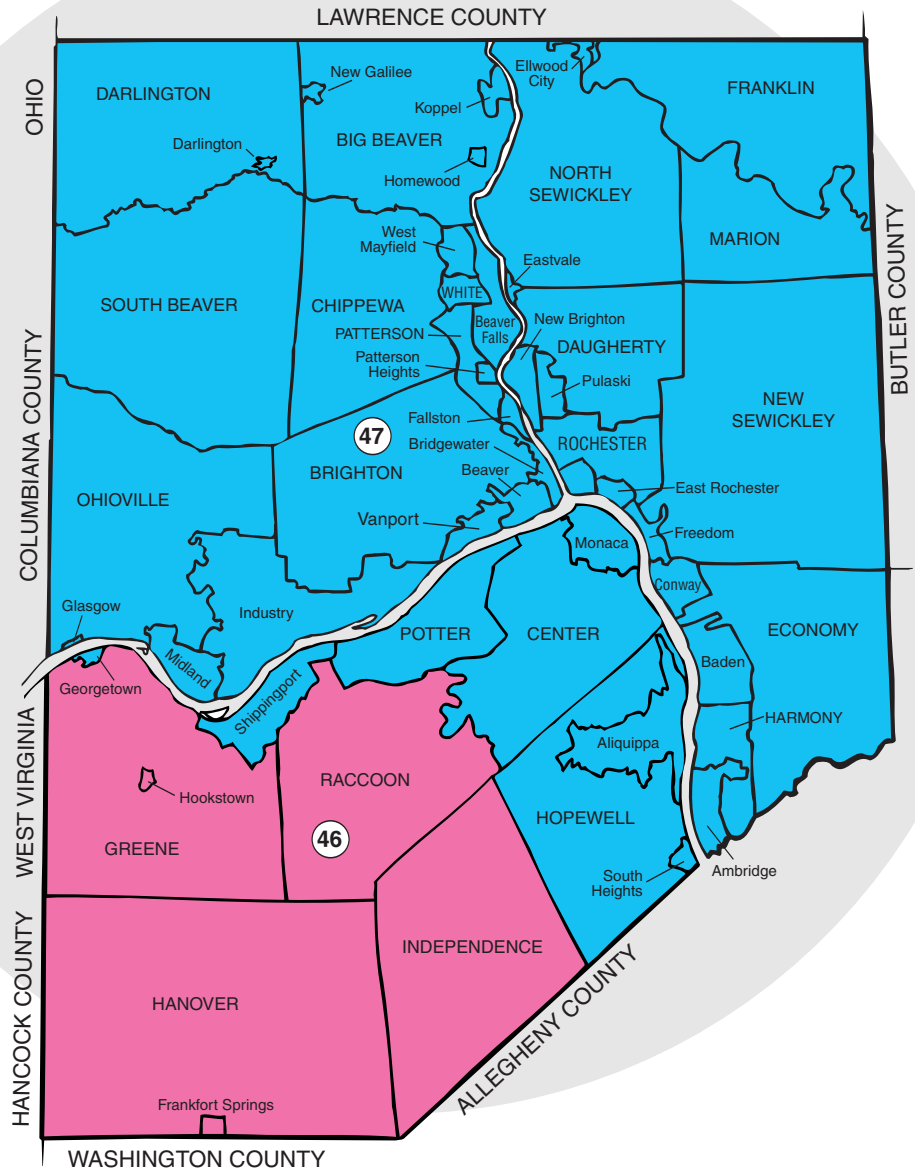
