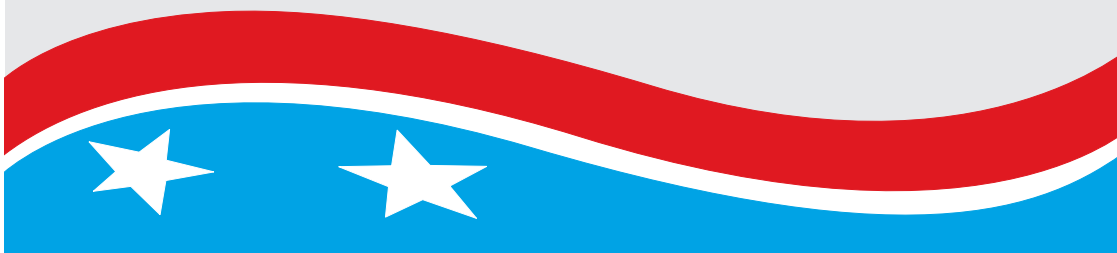

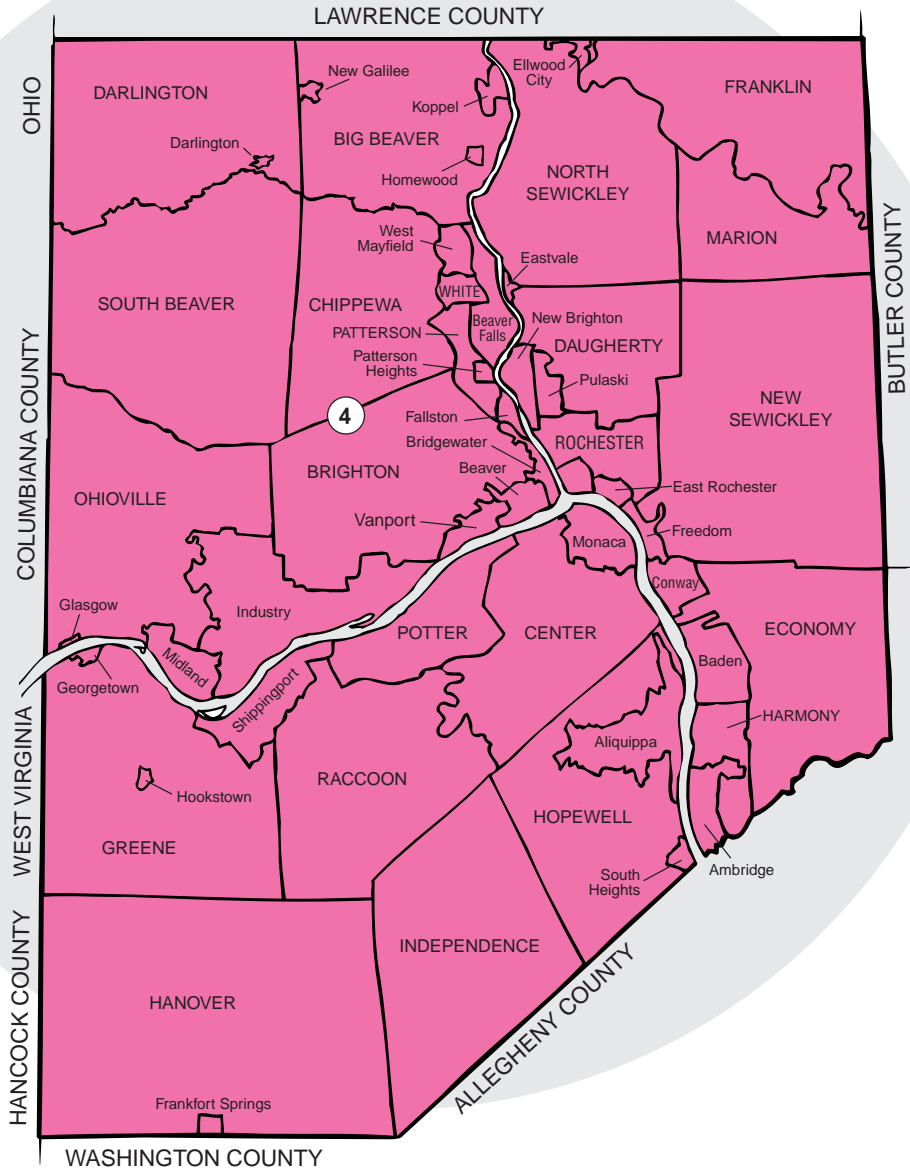

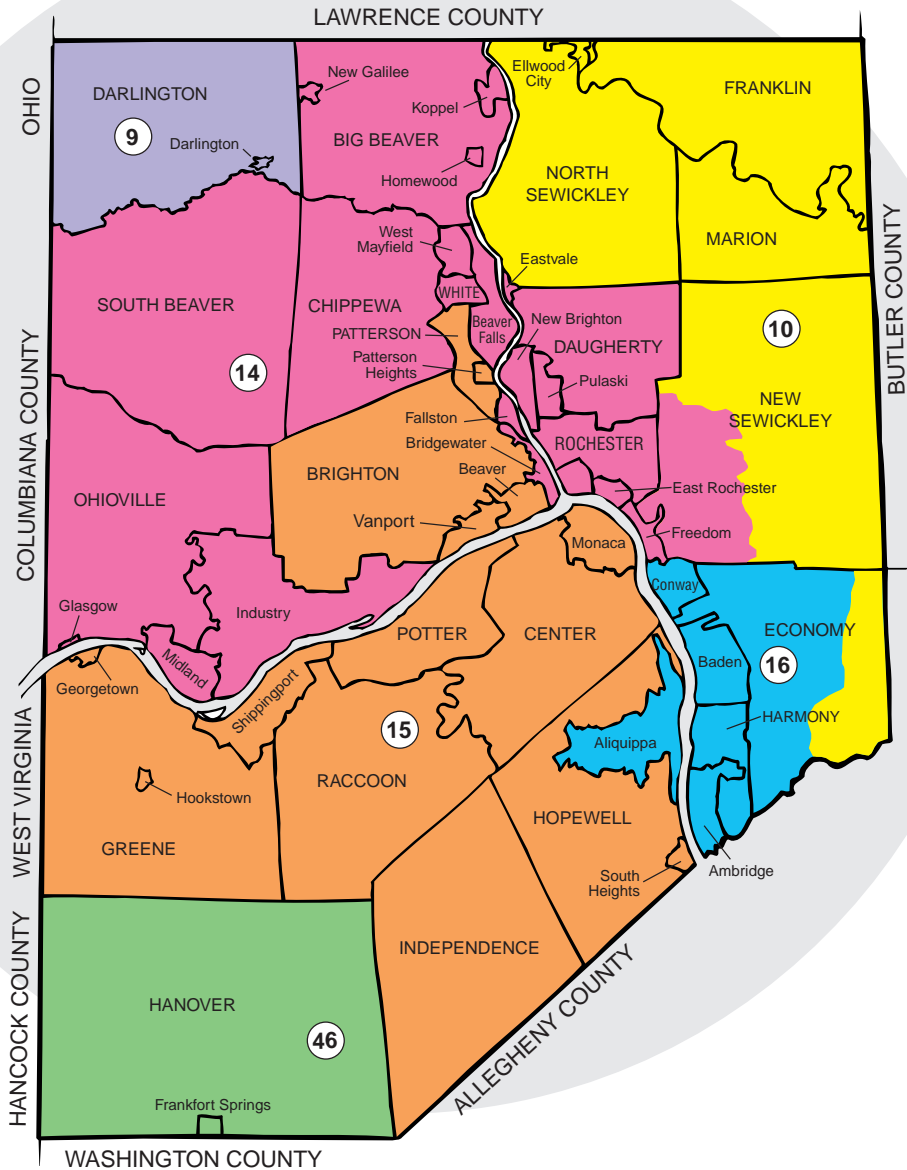


Letter Writing Tips

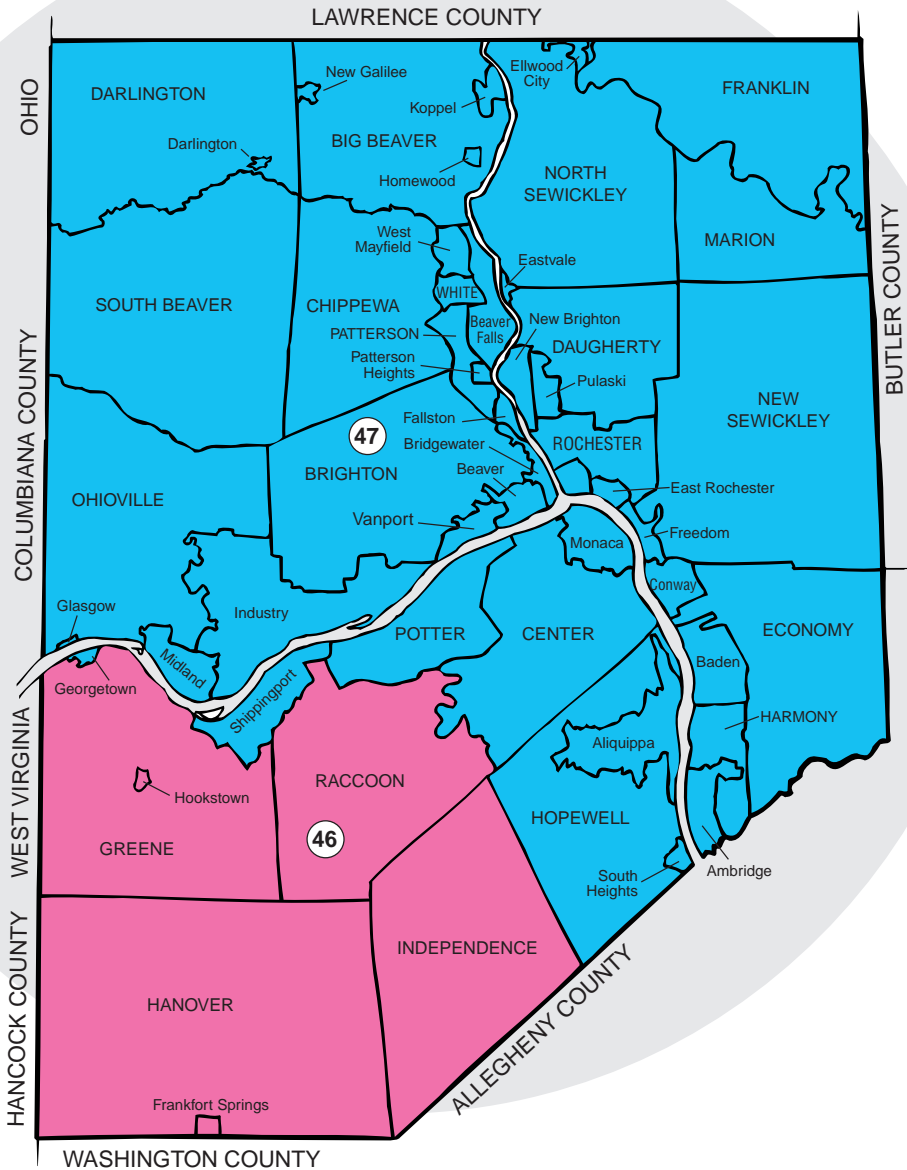
